HANFORD POLICE DEPARTMENT INVESTIGATION LEADS TO SEIZURE OF 4,700 POUNDS OF ILLEGAL FIREWORKS

Suspect, who had prior experience with military ordnance, facing long list of charges

HANFORD, CA – Hanford Police Chief Stephanie Huddleston announced the results of an investigation into an elaborate illegal fireworks sales operation on Friday morning, culminating in the arrest of a Hanford man and the seizure of 4,772 pounds of illegal fireworks.

Hanford Police Street Crimes investigators arrested 33-year-old Reon Branche after serving a search warrant at his home on Lincoln Street in Hanford and discovering illegal fireworks for sale, items used to make homemade fireworks, a homemade firearm, and a MK-76 practice bomb. Because it was not known if the practice bomb posed a safety threat, officers exited the home and evacuated homes in the immediate area. The Central Valley Regional Bomb Squad along with Explosive Ordnance Disposal technicians from the 144th Fighter Wing in Fresno eventually deemed the device to be inert.

The Hanford Fire Department assisted with evacuation efforts before transporting the seized fireworks to Fire Station 2, where they were catalogued and weighed.

“Every year, illegal fireworks cause devastating injuries and millions of dollars in property damage,” Huddleston said. “This major takedown has made the community safer, but for anyone else who may be thinking of using or selling illegal fireworks, our message is simple: don’t do it.”

Branche was booked into the Kings County Jail but has since posted bail. He is facing the following charges.

Residents are reminded that they will be fined \$1,000 for using illegal fireworks and should only use fireworks that have the "Safe and Sane" label.
