**REQUEST FOR BIDS RFB 2026-17**  
**ANNUAL CONTRACT FOR FIRE HYDRANT REPAIR AND REPLACEMENT SERVICES**

BIDS will be received electronically through BidNet Direct's California Purchasing Group website below until **2:00 p.m. on Thursday, February 12, 2026**, for an Annual Contract for Fire Hydrant Repair and Replacement Services, at which time they will be publicly opened digitally and posted for performing work in accordance with the Scope of Work for this project.

**Proposer Teleconference:** A non-mandatory, informational proposal teleconference has been scheduled for **Thursday, January 29, 2026 beginning at 10:00 a.m.** To register for the teleconference, please email the attendee's contact information to [purchasing@hanfordca.gov](mailto:purchasing@hanfordca.gov) and a link to the teleconference will be emailed to you. This meeting is an opportunity for interested proposers to ask questions regarding the project and the Request for Qualification requirements.

**CONTRACT DURATION:** The initial agreement will be for a one-year term with the option to renew for up to two (2) additional one-year terms.

**LICENSE REQUIREMENTS:** The Contractor shall maintain and provide proof of appropriate Current Certification /Licensure certificates of competency from the Office of the State Fire Marshal of California allowing the contractor to complete the work on Fire protection systems. Such Licensures/ Certificates are either C-16 or OSFM "A" License. Automatic Extinguishing Systems (AES) Type 1 license from [CAL FIRE OSFM](#) to engage in the business of installing, maintaining, or testing water-based fire protection systems for hire. Contractor must also be registered with the DIR prior to submission of bid.

**LOCAL VENDOR PREFERENCE:** In an effort to encourage local businesses to provide goods and services to the City, the Council has enacted a Local Vendor Preference policy. The Local Vendor Preference policy will apply to any business that has a fixed business address within Hanford City limits. A Post Office Box will not be accepted as a business address. The City reserves the right to request proof of the City of Hanford address.

**PREVAILING WAGE:** The State of California General Prevailing Wage Rates are hereby incorporated into this contract by this reference. If awarded the contract, Consultant will not pay less than the latest General Prevailing Wage Rates of the State of California (including any and all amendments thereto) to each employee working in connection with this Contract.

This project will be subject to all applicable State Determinations for all trades. The wages are set forth in the General Prevailing Wage Rates for this project, available from the following website: <http://www.dir.ca.gov.dlsr.PWD/index.htm>.

Consultants must comply with all State regulations applicable to this contract, including prevailing wages. Awarded contractor will be required to furnish electronic payroll records for project to the Labor Commissioner. The Contractor must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex or national origin.

**USE OF SUBCONSULTANTS:** The proposal may include subconsultants and should delineate the responsibilities of each of those participants within your proposal. However, the City will recognize the

party legally signing the Bid Proposal as the prime consultant and contracting party, who as such, will assume ultimate responsibility for ensuring compliance with the specifications, terms and conditions of this request for qualifications.

**THE CITY OF HANFORD AFFIRMATIVELY ENSURES** that Minority Business Enterprises (MBE) and Disadvantaged Business Enterprises (DBE) will be afforded full opportunity to submit proposals in response to this notice. Individuals and/or entities submitting proposals to the City of Hanford will not be discriminated against on the basis of race, religious creed, color, national origin, ancestry, physical or mental disability, medical condition, genetic information, marital status, gender, gender identity or expression, age, sexual orientation, or military and veteran status in any consideration leading to the award of the contract.

No qualified disabled person shall, on the basis of disability, be excluded from participating in, be denied the benefits of, or otherwise be subjected to discrimination under any program or activity leading to the award of a contract.

The right is reserved by the city of Hanford to reject any or all proposals, to waive any irregularities or informalities not affected by law, to evaluate the proposals submitted and to award the contract according to the proposal which best serves the interest of the City. All products used or developed in the execution of any contract resulting from this RFQ will remain in the public domain at the completion of the contract.
